4. Pre-bid meeting shall be held at *NVPL, Tripureshwor* at 1:00 pm on 2078/11/17 for tender.
5. Sealed bids must be submitted to the *NVPL, Tripureshwor* before **12:00 PM on 2078/12/02**. Bids received after this deadline will be rejected.
6. The bids shall be opened in the presence of Bidders' representatives who choose to attend at **2:00 PM** on 2078/12/02 at the office of *NVPL, Tripureshwor*. Bids must be valid for a period of *90 days for tender counting from* the date of bid opening and must be accompanied by a bid security as mentioned above which shall be valid for 120 days of the tender.
7. The bidders shall submit their modification or withdrawal in initial method of bid submission only. Modification or withdrawal in other form shall not be accepted.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Matters not covered by the notice shall be in accordance with the Public Procurement Act, 2063: Public Procurement Regulations, 2064 and their amendments.
