4. Pre-bid meeting shall be held at *NVPL, Tripureshwor* at 1:00 PM on **14th September, 2021** for tender.
5. Sealed Bids must be submitted to *NVPL, Tripureshwor* on or before **12:00 PM**, on **30th September, 2021** for tender.
6. Bids shall be opened in the presence of bidder's representatives, who choose to attend at **2:00 PM** on **30th September, 2021** for tender at the office of *NVPL, Tripureshwor*. Bids must be valid for a period of **90 days for tender** counting from the day of bid opening and must be accompanied by bid security as mentioned above which shall be valid for minimum 120 days for tender.
7. The bidders shall submit their modification or withdrawal in initial method of bid submission only. Modification or Withdrawal in other form shall not be accepted.
8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and security validity shall be recognized with effect from the original bid submission deadline.
9. Matters not covered by this notice shall be in accordance with Public Procurement Act, 2063; Public Procurement Regulations, 2064 and their amendments.
